

Lonedell R-14 Scholarship

Scholarship Information

The amount awarded for Scholarships each year shall be determined by the Lonedell R-14 Scholarship Committee based on the availability of funds and the numbers and types of requests.

Scholarship By-laws:

1. Scholarships shall be awarded each year to individuals who are committed to continuing their education. Scholarships may be awarded up to four times within five years of graduating high school. We do not pay for Masters classes.
2. Scholarships may be used for four year, two year, or trade schools. We will not pay for apprenticeships through job training.
3. Applications shall be distributed in January to St. Clair High School, Grandview High School, Lonedell R-14 School, or go to our website: <https://www.lonedell.org>.
4. Anyone graduating from the eighth grade at Lonedell R-14 School may obtain a scholarship application form.
5. Applications submitted by the first school day in April before 3:00 pm shall be considered. For example, if April 1 is a school day, the application will be due April 1. If April 1 falls on a weekend, the application will be due on the following day that school is in session. The Lonedell R-14 Scholarships will be awarded during the eighth grade graduation ceremonies. Recipients of scholarships will be notified by the end of the first week of May.
6. Scholarship payments will be made to the individual to be used for college expenses or fulfilling educational needs and goals.
7. If, for any reason - health, scholarship, personal desire, or any other reason - the scholarship recipient withdraws or is dismissed from the school before the end of the scholarship period, the recipient agrees to repay the Lonedell R-14 School the total amount expended. At the discretion of the Lonedell Scholarship Committee, such repayment may be permitted in installments.

Lonedell R-14 Scholarship

Applications submitted by the first school day in April before 3:00 pm shall be considered. For example, if April 1 is a school day, the application will be due April 1. If April 1 falls on a weekend, the application will be due on the following day that school is in session. Late applications will not be considered.

Application Requirements

- A recent photo (cannot be the same as last year and must be a wallet size or larger)
- Two letters of reference (cannot be the same as last year if applied for scholarship then)
- Copy of your high school or college transcript with a cumulative minimum GPA of 2.5.

(If you previously submitted an application that included your transcript, another copy of your high school transcript is not necessary as it is already on file. A copy of your most recent grades must be submitted).
